in UK (+ N. Irl)



●EXPORT CC FEES (UK→SK/CZ/AT/HU)

€ 95 T1 or T2 up to 500k GBP /including ENS/

+ 0,1 % of invoice value - min. 15

€ 7 per each extra commodity code (1 is for free)

NO CC FOR SPIRITS and WINE (BEER is OK) or PERSONAL EFFECTS !!!

€ 65 / EUR1

€ 50 / ATR

€ 100 (penalty for any change or doc. cancelation)

●IMPORT CC FEES (SK/CZ/AT/HU→UK)

€ 100 (EX doc. closure)

€ 7 per code (1 commodity code is for free)

0 € T-form Closure (when we do import declaration)

€ 40 deferment use + 0.6% of VAT + Duty amount / FAS payment

€ 100 penalty for late payment

(FAS payment must be made by 24 hours)

€ 100 penalty for any change in customs docs.

(in case of cancelation 100 € + T1 guarantee charges)

FOR GB IMPORTS – we are using simplified imports to allow goods to flow. There is no need for an import entry at the border. The driver (traveling from EU to GB) will not stop in Dover. You will send documents from export, commercial invoice etc to agent in Dover as soon as export is complete, then they will do clearance, and once clearance is done they will let you know, and then you can go straight to delivery. To do this you need to select 'Deferred VAT accounting' - this is only for first 12 months... (until Jan. 1st) So then you will receive SAD document which has VAT cost on it and customer can pay VAT (and re-claim it) on their VAT return.

Please note that the customs procedure must be processed on both sides - it means that you have to open customs docs. in UK (T1) and close this document in country of destination (2 x charges for cc).

CARRIER'S HAULAGE:



1. client (consignee) will send all documents which are required for import customs clearance
2. ZOBORTRANS will arrange import cc via our agent
3. delivery to cnee's warehouse after customs clearance
4. consignee will receive customs debt and will arrange pay VAT and DUTY (in 10 days)

NON CARRIER'S HAULAGE:

1. ZOBORTRANS will provide T1 document and ETA to customs office
2. cnee will arrange import customs clearance via own agent
3. MAX 2 hours free for customs clearance / 50 € for each extra hour
4. delivery to cnee's warehouse after customs clearance

CARRIER'S HAULAGE:



1. zákazník (príjemca) pošle všetky potrebné dokumenty na zastupovanie v colnom konaní
2. ZOBORTRANS zabezpečí colné konanie prostredníctvom svojho agenta
3. následne po vyclení dodáme tovar príjemcovi na sklad
4. príjemca dostane colný výmer a zaplatí CLO a DPH priamo na účet štátnej pokladnice (do 10 dní)

NON CARRIER'S HAULAGE:

1. ZOBORTRANS nahlási príchod vozidla na colnicu a zašle T1 dokument
2. zákazník si zabezpečuje colné konanie prostredníctvom svojho agenta
3. MAX voľný čas na vyclenie sú 2 hodiny / extra 50 € za každú načatú hodinu
4. následne po vyclení dodáme tovar príjemcovi na sklad
